Per Board policy 6.702, "all fundraising activities, including online fundraising activities, must have written approval from the principal and Director of Schools or designee." Therefore, employees who wish to use online sites to solicit items or funds for MCS shall complete the attached fundraising form, get all the proper signatures/approvals, and receive final approval from the Director of Schools or the Director's designee before establishing an online fundraising site.

- Online fundraisers are passive because no instructional time is used; therefore, there are no limits as to how many may be held by per school. However, the Murfreesboro City Board of Education has made it clear in Board Policy 6.702 that "fundraising in the schools shall be kept at an absolute minimum and shall serve only to provide for goods and/or services, which will enhance the educational objectives of the school."

Law prohibits teachers to solicit for personal property acquisition. Therefore, items received from a successful fundraiser, or a gift card received due to unsuccessful goal attainment, are the property of the school and not of the employee. If there is a chance that such an event should occur, this should be listed on the request form along with the teacher's signature acknowledging an understanding of the law.

No requests should be made for items MCS should try to acquire as the public school entity—either through site-based funding, activity accounts, school fundraisers, or parent organizations.
