1 In order to ensure that homeless students have equal access to the same free appropriate public
2 education as provided to other students, the following shall apply:

3
4 Homeless students are individuals who lack a fixed, regular and adequate nighttime residence
5 and include the following:

- 7 1. Students who are sharing the housing of other persons due to loss of housing, economic
8 hardship or a similar reason; are living in motels, hotels, trailer parks or camping
9 grounds due to lack of alternative adequate accommodations; are living in emergency or
10 transitional shelters; are abandoned in hospitals; or are awaiting foster care placement.

 - 12 2. Students who have a primary nighttime residence that is a public or private place not
13 designated for or ordinarily used as a regular sleeping accommodation for human beings.

 - 15 3. Students who are living in cars, parks, public spaces, abandoned buildings, substandard
16 housing, bus or train stations or similar settings.

 - 18 4. Migratory students who meet one of the above described circumstances.

20 Enrollment/Placement

21
22 Murfreesboro City Schools will consider the best interests of the student with parental
23 involvement in determining the best school placement. To the extent feasible, and in accordance
24 with the student’s best interest, the student should continue his/her education in the school of
25 origin, except when contrary to the wishes of the parent or guardian. If the student is
26 unaccompanied by a parent or guardian, the homeless coordinator will consider the views of the
27 student in deciding where the student shall be educated. The choice regarding placement shall be
28 made regardless of whether the student lives with the homeless parent(s) or has been temporarily
29 placed elsewhere.

30
31 The school selected shall immediately enroll the homeless student even if the student is unable to
32 produce records normally required for enrollment such as previous academic records,
33 immunization records, proof of residency or other documentation. However, the system may
34 require a parent or guardian of the student to submit contact information.

36 The system shall provide a written explanation, including a statement regarding the right to
37 appeal, to the homeless student's parent/guardian, or to the homeless student if unaccompanied,
38 if the system sends the student to a school other than the school of origin ("school of origin" is
39 defined as the school that the student attended when permanently housed or the school in which
40 the student was last enrolled) or other than a school requested by the parent or guardian.

41
42 If a dispute arises over school selection or enrollment in a school, the student shall be
43 immediately admitted to the school in which enrollment is sought, pending resolution of the
44 dispute. The student or parent/guardian shall be referred to the system homeless coordinator
45 who will carry out the dispute resolution process as expeditiously as possible.

46 47 Services

48
49 Each homeless student shall be provided services comparable to services offered to other
50 students in the system including transportation services, educational services for which the
51 student meets eligibility criteria such as educational programs for disadvantaged students,
52 students with disabilities and gifted and talented students, school meals programs, preschool
53 programs, before and after school programs and programs for students with limited English
54 proficiency. Homeless students will not be segregated in a separate school or in a separate
55 program within a school based on the student's status as homeless.

56 57 Transportation

58
59 In the event that it is in the best interest of the homeless student to attend the school of origin,
60 transportation to and from school shall be provided at the request of the parent/guardian or, in the
61 case of an unaccompanied student, the homeless coordinator. If the student's temporary housing
62 is outside the system of the school of origin, the Murfreesboro City Schools will work with the
63 school of origin to agree on a method to apportion the responsibility and costs of transporting the
64 student. If an agreement cannot be reached, the costs will be shared equally.

65 66 Records

67
68 Any records ordinarily kept by the school, including immunization records, academic records,
69 birth certificates, guardianship records and evaluations for special services or programs of each
70 homeless child or youth shall be maintained so that appropriate services may be given the
71 student, so that necessary referrals can be made and so that records may be transferred in a
72 timely fashion when a homeless student enters a new school system. Copies of records shall be
73 made available upon request to students or parents in accordance with the Family Educational
74 Rights and Privacy Act.

75 76 Coordinator

77
78 The Board designates the following individual to act as the system's homeless coordinator:

79
80 Coordinator of Federal Projects and School Support Services

81
82 The system shall inform school personnel, service providers and advocates working with the
83 homeless families of the duties of the system homeless coordinator. The homeless coordinator
84 shall ensure that:

85

- 86 1. Homeless students are identified by school personnel and through coordination activities
87 with other entities and agencies.
88
- 89 2. Homeless students enroll in, and have a full and equal opportunity to succeed in schools
90 in the system.
91
- 92 3. Homeless families and students receive educational services for which such families and
93 students are eligible, including Head Start and preschool programs administered by the
94 system and referrals to health care services, dental services, mental health services and
95 other appropriate services.
96
- 97 4. The parents and guardians of homeless students are informed of the educational and
98 related opportunities available to their children and are provided with meaningful
99 opportunities to participate in the education of their children.
100
- 101 5. Public notice of the educational rights of homeless students are disseminated where such
102 students receive services such as schools, family shelters and soup kitchens.
103
- 104 6. Enrollment disputes are mediated in accordance with the law.
105
- 106 7. The parent or guardian of a homeless student and any unaccompanied youth is fully
107 informed of all transportation services, including transportation to the school of origin
108 and is assisted in accessing transportation to the school selected.
109
- 110 8. Unaccompanied youths will be assisted in placement or enrollment decisions, their views
111 will be considered and they will be provided notice of the right to appeal.
112
- 113 9. Students who need to obtain immunizations, or immunization or medical records, will
114 receive assistance.
